#### a. Tax Exempt - Denial

CHIEF SNEVE presented a letter of tax exempt denial. We have been paying taxes on Station 3 so we filed the proper paperwork to receive a tax exemption and was denied. So, we will try again next year.

COMMISSIONER JOY: What was the reason for denying us? CHIEF SNEVE: They said that we did not fit into the tax exemption. That is the only station that we pay tax on. We pay IDL very little for Station 7. CARMEN stated that in the past it was exempt and for some reason the County removed our exempt status saying we did not meet the requirements. CHAIRMAN HISE: How much are we paying for taxes? CARMEN: \$865.91 per year. CHIEF SNEVE: We only own the building; the land is on a 99-year lease.
