**CALL TO ORDER**

CHAIRMAN JOY called the meeting to order at 04:34

**COMMISSIONERS PRESENT:** Commissioner Wienclaw, Chairman Joy

**OTHERS PRESENT:** Chief Sneve, Secretary Saranto and Randy Primmer

**AMEND AGENDA**

CHAIRMAN JOY requested to amend the agenda to add Kelly Dionne with Express Employment Professionals. COMMISSIONER WIENCLAW 2<sup>nd</sup> the motion.

**EXPRESS EMPLOYMENT PROFESSIONALS**

CHIEF SNEVE stated he had met with Mr. Dionne about a replacement for the admin. asst. position. Express Employment Professionals had presented Chief Sneve and the Board with a contract for services. This contract included 720 hours of service before becoming an employee of Worley Fire and a service fee 1.6% would be charged. If Worley Fire wanted to make this person an employee before the 720 hours was up the service fee would still be owed to Express Employment. He also mentioned that wages in the last several months have gone up in the Coeur d Alene area. The contract figures were based on an hourly rate of \$16.00 to \$18.00, and that he had a person in mind who would be available to start at the end of November.

CHAIRMAN JOY stated the Board would like to get a person with knowledge of governmental accounting and audit experience. Mr. Dionne shared with the Board an employee with those skills would cost them more than what he had stated in the contract and the person he had selected would not fit that criteria. If still interested he would have to search for qualified applicants.


