We do not have any EMTs and we're not going to pay overtime to participate. There really is no benefit for the citizens of our district. Chairman Hise stated if they wanted us to participate they could pay and we could bring in our off-duty and pay overtime wages.

CHIEF SNEVE advised that when Chairman Hise and I are on the ambulance crew for Iron Man we cannot leave the race if we have an emergency in our own district. COMMISSISONER JOY stated he would then object to participating because our obligation is to the taxpayers in our district. PRO-TEM COMMISSIONER MATT DRECHSEL stated this is just a PR thing that we're doing for the Iron Man community. COMMISSIONER JOY thinks the only way that it would be appropriate for us to participate would be if they would provide us enough money to have our off-duty crew come in and get paid overtime.
